# PUBLIC SERVICE LOAN FOREGIVENESS PROGRAM

As an employee of the Montana University System (MUS), you may qualify for the Public Service Loan Forgiveness (PSLF) Program. PSLF is a federal program that forgives the remaining balance on direct loans after 120 qualifying monthly payments under a qualifying repayment plan while an individual is working full-time for a qualifying employer. The MUS is a qualifying PSLF employer.

Last year, the U.S. Department of Education announced a time-limited waiver to allow borrowers to receive credit for past periods of repayment that would otherwise not qualify for loan forgiveness. Under the temporary waiver, any prior period of repayment counts as a qualifying payment, regardless of loan program, repayment plan, or whether the payment was made in full or on time, provided the employment requirements are satisfied.

Many in the MUS may have applied for PSLF and had their application rejected because they did not meet the PSLF criteria. The MUS encourages employees who may be eligible for relief under the program to apply or reapply, even if an application was previously submitted and rejected by the U.S. Department of Education.

The waiver is only available for a limited time. The deadline to submit the PSLF Application for the waiver is **October 31, 2022**. Individual employees are responsible for submitting all necessary forms to the U.S. Department of Education. Requests for employment certification should be directed to campus human resources.

To provide additional clarity for eligibility and to assist a broader range of employees, the MUS will consider a teaching load of 9 credits or more per semester to be "full-time" employment for the purpose of PSLF. This interpretation aligns with the U.S. Department of Education's recent proposal to overhaul the PSLF Program. The MUS's interpretation of full-time employment is only applicable to PSLF through the waiver period or until the U.S. Department of Education adopts the revised definition of "full-time" employment as proposed, whichever occurs earlier. This definition only applies to the PSLF Program. It does not apply to benefit eligibility determinations in the MUS or for purposes of the Affordable Care Act or to faculty workload analysis or assignments.

### BEWARE OF TEXT MESSAGE PHISHING ATTACKS

We continue to see an increase in text message phishing attacks, known as "smishing" (because of the SMS format text messages rely on). Just like with email-based phishing, you should be suspicious if you receive a text message with any of the following characteristics:

- From an unknown phone number or address
- Tells you that you've won something
- Urgently requests you to do something
- · Contains a link
- Asks you to reply with personal information or credentials
- Uses a generic salutation like "Hello there!" or "Sir/madam"

If you do suspect a smish, don't respond or click any links, delete the message from your phone, and block the sender. Be secure out there!
