Thank you for taking the time to review this application. The GPA Midstream is a trade association with primary membership being employees of companies who are involved in the gathering, processing, marketing, and transportation of natural gas, natural gas liquids, and crude oil as well as companies which supply equipment and services for this market.

The Rocky Mountain Chapter of the GPA Midstream is pleased to announce plans to award multiple scholarships for 2022. In addition, top award winners receiving a scholarship of \$5,000 or more will also receive a copy of GPSA data books on a flash drive. In 2021, we awarded \$55,000 to students attending our target universities located in the Rocky Mountain Region.

Applicants must meet the following criteria:

1. The student has demonstrated a strong interest in the Oil and Gas Processing Industry.
2. The student is pursuing an engineering degree and maintaining a 2.8 or better Grade Point Average (4.0 scale).
3. The student has achieved junior or senior status as an undergraduate or is currently enrolled in a graduate program.
4. The student is a U.S. or Canadian citizen.

Potential candidates must complete the application and required essay. The essay (1,000 word maximum) should focus on the candidate's interest in the oil and gas processing industry and how the candidate expects to use their degree in this industry. Our Scholarship Committee will review applications and essays and make a final decision in late October. Please note that verification of submitted Grade Point Average (GPA) may be requested from selected applicants.
