

#### **SAFETY NOTICE**

#### Effective May 1, 2012



As part of Troy Mine's support of our bear safety awareness program and employee off the job safety, the company will reimburse employees for the purchase of approved bear spray.

Per Montana Fish, Wildlife & Parks, approved bear deterrent spray will have an EPA Registration number on the can, usually on the front label at the bottom. The can should read "Bear deterrent for use on wildlife only."

#### It's Easy!!!

Just make your bear spray purchase at a store of your choice and bring your receipt to Renee Guisewite for processing your reimbursement.



#### "Let's take Safety Home"

Troy Mine is encouraging all employees to further practice safety with the introduction of a company-sponsored safety at home purchase program geared toward the family and home.

This program allows employees to purchase safety items, at a store of their choice, in the amount of up to \$100.00 per calendar year. (Note: This is exclusive of the bear spray reimbursement program).

Examples of such safety purchases are smoke alarms and batteries, fire extinguishers, life vests for boating, first aid kits, windshield wipers, hand tools with up-to-date guards, a GPS for hunting or winter sports, and helmets for bicycles. Use your imagination to assist you in keeping you and your family safe at home and in recreation.


Your request for reimbursement can be made as often as monthly and must be a minimum total of \$25.00 and an annual total of \$100.00 per calendar year. Make your purchase(s) and bring your receipt(s) to Renee for processing.

## **TROY MINE, INC**

Up to 205 Employees in 2012 ~ \$1.4 MM/month payroll & benefits

Currently 55 employees; possibly 100 + by year-end



 Scheduled to return to limited production Q4 2014 and full production in mid 2015 (production operations suspended in December 2012)

• First production in 1981...Life-of-Mine is currently estimated to be 12 years at an average production rate of 1.4 million oz. silver and 10 million lbs. copper







Discovered by Kennecott in 1963, explored by Asarco 1974-1983 131 holes drilled totaling 122,035 feet of core Acquired by Revett in 1999

#### **ROCK CREEK PROJECT**

- The Rock Creek project is one of North America's largest undeveloped silver/copper deposits...same geological/geochemical characteristics as Troy
- Life-of-Mine at Rock Creek is forecasted to be over 30 years at an average annual production rate of 6.0 million oz. silver and 50 million lbs. copper
- 350 new payroll jobs assumed at full production
- Supplemental Environmental Impact Statement may be released for public comment as early as late 2014
- Multi-agency teams and contractors working diligently to prepare comprehensive analysis

- Provide effective long-term stewardship and "Best Use" planning for Revett land holdings during, and after, mining operations and reclamation




#### **BEYOND CLOSURE**

Not-for-profit entity created in late 2012 to carry commitments "beyond closure"

- Plan to add outside, independent Directors to founding Board
- Initial start-up funding from Corporation
- Foundation seeks to collaborate with diverse groups/individuals
- Increase opportunity for broader pursuits beyond Corporate interests
- Likely vehicle to deliver best long-term management of unique lands in partnership with others





# HIGH DENSITY PROPERTY DEVELOPMENT






#### LIMITED CORRIDORS


- Figure from: Forest Legacy Project Stimson Conservation Easement

- Mt. Vernon/Troy Mine along recognized corridor








## **GEOGRAPHY OF ROCK CREEK**




#### How to get there:
