


Benbow Portal Concept





Benbow Portal Location





Purpose

- Facilitate exploration of the Blitz Project Area
- Concept drive a 6,000 ft. exploration portal to access the eastern extent of the Blitz Project Area to evaluate ore grade, ore continuity, and rock conditions.
- Long-term ventilation exhaust; secondary escape-way; limited personnel/supply access
- □ Following Development ore; waste-rock; water would be directed to 5000E Portal at the Stillwater Mine.

- Willingness to be Adaptive









Benbow Mitigation Plan

- Commitment under the GNA
 - Legally Binding
 - Mutual Compromises
- Not addressed via the Plan/ROD
 - Agencies had no legal authority
- Long-Term Waste Rock and Tailings Storage (Benbow Area)
- Waste Rock Beneficial Use
- Water Replacement
- Travel/Traffic Limitations
